M.SC. in Periodontology

For the course start in September 2024, we are offering the following scholarships:

- Scholarship for employees of RWTH Aachen University and University Hospital of RWTH Aachen
- Scholarships for young dentists
- Scholarships for global dentists

Application deadline: April 15th, 2024

RWTH International Academy offers the study course M.Sc. in Periodontology of RWTH Aachen University in cooperation with the Clinic for Operative Dentistry, Periodontology and Preventive Dentistry of the University Hospital RWTH Aachen.

The course offers dentists the opportunity to become highly qualified specialists in periodontology. The master program includes 8 modules over one year. Each module includes live online-seminars and two days of hands-on training & lectures in Aachen, Germany. The attendance days are organised in blocks. To optimally integrate this master's degree into your work routine, each module is supported by digital teaching and learning content that can be accessed at flexible times. The last semester is dedicated to the preparation and compilation of a master thesis on a periodontal disease related topic.

Admission Requirements for the master course are a successfully completed studies in dentistry, the license to practice as a dentist or a dental education completed abroad, at least two years working experience as a dentist in a clinic or practice, and English language proficiency (level B2).

The basic requirement for receiving a scholarship is the fulfilment of the formal and professional admission requirements. We therefore ask you to upload all required documents to the application portal **www.online.rwth-aachen.de** in time. If your application for the master program is not completely uploaded in the application system and checked by all needed examining bodies, your application for a scholarship cannot be considered.

Please note that you can only apply for one of the following scholarships.

Do not upload other documents than the ones requiered. The required information for a complete application can be found below.

Which requirements do I have to meet to apply for a scholarship?

Scholarship for young dentists

This scholarship is awarded to young dentists with a maximum of four years of clinical experience as a dentist. Please submit a proof of experience and a meaningful letter of motivation.

Scholarship for global dentists

This scholarship intends to support highly qualified dentistry from around the globe to pursue a master's degree program at RWTH Aachen University. Please submit a meaningful letter of motivation why you should be awarded.

Scholarship for employees of RWTH/UKA

In your letter of motivation, you should particularly explain your commitment and role at RWTH / UKA. The proof of membership of RWTH / UKA should be provided by a corresponding letter of recommendation by the employer.

Scope of the scholarships

Scholarships for young dentists & global dentists

Scholarship for employees of RWTH/UKA

- ► Reduction of tuition fees by 50%
- Scholarship amount: 11.775€

- ► Reduction of tuition fees by 100%
- Scholarship amount: 23.550€

The number and number of scholarships may vary depending on availability and financial feasibility.

For all scholarships, the RWTH semester fees as well as maintenance and travel costs are borne by the participant.

The sum will be credited against the tuition fees to be paid. A pay-out of the scholarship amount is excluded. A combination of the scholarships and a legal entitlement to a scholarship are excluded. Special conditions apply in the event of losing the scholarship requirements during the course.
